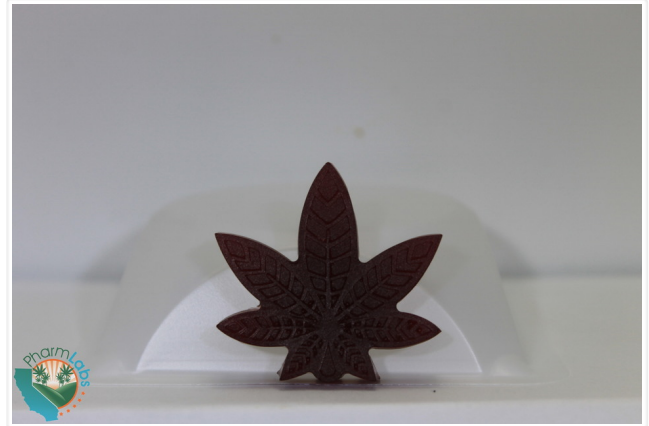
Laboratory note: The estimated concentration of the unknown peak in the sample is 0.04% | Currently PharmLabs laboratory can not confirm an unidentified peak in your chromatogram due to interference (only with highly concentrated D8 products) from which we believe to be either (+)- Δ^8 -THC or Δ^9 -THC. At this time there are no reference standards available for (+)- Δ^8 -THC. (+)- Δ^8 -THC is a different compound from the main (-)- Δ^8 -THC cannabinoid and, therefore, these two compounds may have different efficacies. Using the most advanced instruments and techniques available, the separation of (+)- Δ^8 -THC and Δ^9 -THC is problematic for the scientific community as a whole. PharmLabs believes the unidentified peak to be a combination of (+)- Δ^8 -THC and Δ^9 -THC with the majority, if not all, of the concentration being (+)- Δ^8 -THC. Total (+/-) Δ^8 Concentration is estimated to be: 0.36%
